

Dear SLCC employee:

Your Company offers outstanding convenience and a variety of investment options. Take a look and see what a difference enrolling in the Plan could make in achieving your goals.

Benefit from:

Convenience. Your contributions are automatically deducted regularly from your paycheck.

Tax savings now. Your pretax contributions are deducted from your pay before income taxes are taken out. This means that you can actually lower the amount of current income taxes you pay each period. It could mean more money in your take-home pay versus saving money in a taxable account.

Tax-deferred savings opportunities. You pay no taxes on any pretax earnings until you withdraw them from your account, enabling you to keep more of your money working for you now.

Portability. You can roll over eligible savings from a previous employer into this Plan. You can also take your plan vested account balance with you if you leave the company.

Investment options. You have the flexibility to select from investment options that range from more conservative to more aggressive, making it easy for you to develop a well-diversified investment portfolio.

Online beneficiary. With Fidelity's Online Beneficiaries Service, you can designate your beneficiaries, receive instant online confirmation, and check your beneficiary information virtually any time.

Catch-up contributions. If you make the maximum contribution to your plan account, and you are 50 years of age or older during the calendar year, you can make an additional "catch-up" contribution of \$6,500 in 2021. In addition, during one or more of the last 3 years before normal retirement age, you may be limited to using the greater of the 457 "last-3-years" catch-up or the age 50 catch-up.

Enroll in your plan and invest in yourself today.

Here are answers to questions you may have about the key features, benefits, and rules of your plan.

When can I enroll in the Plan?

Salt Lake Community College will determine which employees are eligible to participate in this Plan.

How do I enroll in the Plan?

To enroll in the Plan, please contact Human Resources to obtain an Enrollment Form. The Enrollment Form will indicate how much you'd like to contribute to your account via payroll deductions. The form should be completed and returned to Human Resources. Then, if you have selected Fidelity Investments as your provider, please contact Fidelity either by calling a Retirement Service Representative on 1-800-343-0860 or log onto Fidelity NetBenefits® at www.netbenefits.com/atwork. The first time you contact Fidelity, you'll need to establish a password. If you're already a Fidelity customer, you can use your existing password. Next, please select your investment elections.

How much can I contribute?

Through automatic payroll deduction, you may contribute up to 100% of your eligible contributions.

What is the IRS contribution limit?

You may defer \$19,500, the maximum IRS limit in 2021, which applies to all employee and employer contributions in all 457 plans in which you participate.

When is my enrollment effective?

Your enrollment becomes effective once you complete the paperwork described above and submit it to Human Resources.

How do I designate my beneficiary?

If you have not already selected your beneficiaries, or if you have experienced a lifechanging event such as a marriage, divorce, birth of a child, or a death in the family, it's time to consider your beneficiary designations. Fidelity's Online Beneficiaries Service offers a straightforward, convenient process that takes just minutes. To make your elections, click on the "Profile" link, then select "Beneficiaries" and follow the online instructions.

What are my investment options?

To help you meet your investment goals, the Plan offers you a range of options. You can select a mix of investment options that best suits your goals, time horizon, and risk tolerance. The many investment options available through the Plan include conservative, moderately conservative, and aggressive funds. A complete description of the Plan's investment options and their performance, as well as planning tools to help you choose an appropriate mix, are available online.

What if I don't make an investment election?

We encourage you to take an active role in the SLCC 457(b) Plan and choose investment options that best suit your goals, time horizon, and risk tolerance. If you do not select specific investment options in the Plan, your contributions will be invested in the Fidelity Freedom[®] Fund - Class K6 with the target retirement date closest to the year you might retire, based on your current age and assuming a retirement age of 65, at the direction of Salt Lake Community College. If no date of birth or an invalid date of birth is on file at Fidelity, your contributions may be invested in the Fidelity Freedom® Income Fund - Class K6. More information about the Fidelity Freedom® Fund - Class K6 options can be found online.

Target Date Funds are an asset mix of stocks, bonds and other investments that automatically becomes more conservative as the fund approaches its target retirement date and beyond. Principal invested is not guaranteed.

What catch-up contribution can I make?

You may elect to make a last-3-years catch-up contribution of up to double the contribution limit in effect (up to \$39,000 in 2021). This contribution may be used in one or more of the three consecutive years prior to the year in which you attain normal retirement age under the Plan. This option gives you an opportunity to catch up on contributions you could have made but did not make in previous years. See your Employee Benefits Office for more information.

When am I vested?

You are always 100% vested in your own contributions to the SLCC 457(b) Plan.

Can I take a loan from my account?

Loans are not available in this Plan.

Can I make withdrawals?

Withdrawals from the Plan are generally permitted when you terminate your employment, have a unforeseeable emergency or the Plan is terminated. Keep in mind that withdrawals are subject to income taxes and possibly to early withdrawal penalties. If you are under age 59½, the taxable portion of your withdrawal is also subject to a 10% early withdrawal penalty, unless you qualify for an exception to this rule.

Any assets distributed from your governmental 457(b) plan will be taxed as ordinary income in the year withdrawn; if you are under age 59½ at the time of the distribution, a 10% early

withdrawal penalty may apply to any amounts which were rolled into the plan from an IRA or a plan other than another governmental 457(b) plan. If the distribution is eligible to be rolled over, but is not directly rolled over to an eligible plan or IRA, 20% mandatory withholding of federal income tax applies. Federal income tax will not be withheld if an eligible plan-to-plan transfer is made to another employer's 457(b) plan that accepts the transfer. Be sure you understand the federal and state tax consequences of any distribution before you initiate one. You may want to consult your tax adviser about your situation.

Can I move money from another retirement plan into my account in the SLCC 457(b) Plan?

You are permitted to roll over eligible pretax contributions from another 401(a) plan, 403(b) plan or a governmental 457(b) retirement plan account.

You should consult your tax adviser and carefully consider the impact of making a rollover contribution to your employer's plan because it could affect your eligibility for future special tax treatments.
